1. Free repair or replacement of refurbished product

If you are not satisfied with your WAVE within the first twelve (12) months from the date of purchase, due to a defect, the WAVE may be returned for replacement by way of a refurbished device or repair, and Golfzon reserves the right in its sole discretion to either repair or replace the unit. Customer will receive a return label upon approved return to return product. If customer uses any other method to return product, customer assumes risk of loss, and is responsible for shipping and handling fees for returning product.

2. Warranty inspection

If these inspections reveal that any of the warranty exclusions provided below apply, the warranty will be void and you will be charged a repair or purchase price for the refurbished product. Once you are notified that the warranty is not applicable and you agree to pay the amount and payment is complete, we will ship the repaired product or refurbished product of the returned device to you.

3. Warranty Exclusions
